From the Pastor



When Abram was ninety-nine years old, the LORD appeared to Abram, and said to him, "I am God Almighty; walk before me, and be blameless. And I will make my covenant between me and you, and will make you exceedingly numerous." Then Abram fell on

his face; and God said to him, "As for me, this is my covenant with you: You shall be the ancestor of a multitude of nations. No longer shall your name be Abram, but your name shall be Abraham; for I have made you the ancestor of a multitude of nations.

Genesis 17:1-5

Covenant. It is a word we use frequently in the U.C.C. We are in covenant with God and Christ; with one another: we are in covenant with our

brothers and sisters of the faith; we are in covenant with the Penn Northeast Conference; we are in covenant with the national offices of our denomination. But what exactly is a covenant?

Many would liken a covenant to a contract. While a covenant has many similarities to a contract, I think there are significant differences, especially the way we use it in relation to faith practices. A contract is a legal document that lays out expectations, responsibilities, and performance between two or more entities. It includes the penalties for failure to deliver on any of these and is enforceable in a court of law. A covenant also lays out expectations, responsibilities, and performance but is more like what was once called a "gentlemen's agreement" made between two parties. It isn't meant to go before a court of law (though promises and covenants have sometimes been taken there). The adherence to the agreement depends on the integrity of the parties involved. God keeps faith with us even when we fail. Jesus tells us when we are making promises not to swear on or by anything, but to let our "Yes" be yes and our "No" be no.

Our covenant is no secret; we made it when we joined the church and our confirmands will make it publicly on Pentecost: we have promised to follow in the ways of Jesus Christ and to spread the good news he brings to all the world. We have promised to love, support and encourage one another in this endeavor. This covenant exists between every entity of the United Church of Christ. In this season of Pentecost let us once again call upon the Holy Spirit to enter our hearts, fill us with fire, and enable us to keep the covenants we have made.

GOOD NEWS

We are all aware of the financial difficulties that most churches are experiencing today. We still have to deal with the expenses of staff, building maintenance, missions and other issues that strain our budgets. The finance committee was recently made aware of a program offered through Amazon where our church can participate in a program that will provide funds through purchases made through them.

The program is very simple. Each time you make a purchase through Amazon, a percentage of that purchase is directed to the church or charity and the percentage can be as high as 10% of the purchase. Many purchases we make through Amazon can be substantial and beneficial to the church. We have decided to take advantage and participate in this program and are asking our congregation to offer its support.

The process is simple. Go to the church website (www.drylanducc.org). Go about half way down the home page and you will see a link to Amazon. When you click on the link you will be taken to your Amazon web page. This will automatically sign you on as a participant for the fundraiser. You will need to sign on through the Dryland web site each time you order for the church to get credit for the purchase. This program is not part of Amazon's Smile program, so you do not sign on to a charity program. Once this is complete, all purchases qualify, and Dryland can benefit.

To participate, you do not have to be a member of Dryland. Anyone can sign on to the program. So, we are asking you to invite your children, grandchildren, aunts, uncles, neighbors, friends, co-workers, etc. to participate in this program. The benefits to Dryland can be far beyond our expectations and ease our financial burdens.

TREASURERS REPORT

The cash receipt and expenditure activity for the period April 1, 2019 thru April 30, 2019 is attached. The category Current-Mission-Property encompasses the options on the weekly giving envelope. These costs cover the basic needs to keep your church operational (i.e salaries, utililties, insurance, property maintenance). The Capital category is refering to the capital section of the giving envelope. The monies here are applied to the loan obtained for the santuary renovation in 2009. Giant Card program is another way to support the church through Giant Markets giving back 5% of total sales made by obtaing a Giant Gift Card.

The Note area is a guide to keep us on target for meeting our commitments.

Our Capital (Mortgage) payment beginning May 15th will be \$1,226.00 per month for 15 years. This is a fixed rate. Expenses for April Capital (Mortgage) reflects our closing costs to have the outstanding loan balance refinanced. Even though the monthly payment decreased, we did not change

the yearly budget number. Our goal is to reach the yearly budget number in order to make extra payments on the loan principal. In doing so, we can pay off the loan ahead of the 15 year loan schedule and save the interest charges that accumulate over the years.

With the covenant made between each one of us and with God, we can support the programs offered by your Dryland family.


